The debarment, initially imposed on August 31, 2023, prompted a comprehensive review and enhancement of BCE's internal compliance measures.

As part of our commitment to aligning with the African Development Bank's integrity compliance expectations and advancing our reinstatement process, we have completed several key milestones in the assessment of our Integrity Compliance Program (ICP) with the support of Burem Forensics:

- 1. Formal Introduction of Consultant:
 On January 27, 2025, Beza
 Consulting Engineers formally
 informed the African Development
 Bank of the engagement of Burem
 Forensics to support the
 development and delivery of our
 ICP.
- 2. Comprehensive Training: From February 10-15, 2025, our team underwent comprehensive training and implementation process with Burem Forensics to ensure our ICP is fully compliant with the Bank's guidelines.
- 3. Submission of Company Policies:
 On February 24, 2025, following
 approval by the Chairperson of the
 Board of Directors, the BEZA
 Policies were formally submitted to
 the Bank for review.
- 4. Submission of SOPs: On March 3, 2025, the Standard Operating Procedures (SOPs), approved by the Chairperson, were formally submitted to the Bank for review and certification.
- 5. Submission of Training Materials:
 On March 10, 2025, supplementary training materials, including assessment quizzes, attendance records, signed acknowledgments, and training session recordings, were submitted to provide complete documentation of the ICP training.
- 6. Submission of Assessment Report:
 On March 12, 2025, the assessment report for the training and ICP implementation was formally submitted to the Bank via Burem Forensics.
